Protective Behaviours

Protective Behaviours is a personal safety program that teaches children skills and strategies to recognise and respond to a range of unsafe situations. The program is applicable in contexts including child abuse, family violence, and bullying. Protective Behaviours is underpinned by two core themes:

We all have the right to be safe and feel safe at all times.

We can talk with someone about anything, no matter what it is.

The key learning areas of the WACSS Protective Behaviours program are:

- Theme 1 ‘We all have the right to be safe and feel safe at all times’ and Feelings (Early) Warning Signs
- Safety Check
- Theme 2 ‘We can talk with someone about anything, no matter what it is’ and Networks
- Safe and Unsafe Secrets
- Persistence
- Body Safety
- Public and Private
- Personal Space and Consent
- The Right to Say ‘No’

Child Protection, Mandatory Reporting & Grooming

Recognising and responding to child abuse and neglect are essential skills for people who work with children and young people. The way in which an adult responds to a child experiencing harm can have a lasting impact on their recovery.

Our facilitators share sector knowledge and experience to build the capacity of participants to identify and respond to child abuse, neglect, and grooming. This workshop meets requirements for NQS, and both government and non-government school registration.

Child Protection & Mandatory Reporting workshop content:

- Defining physical abuse, emotional abuse, neglect and sexual abuse
- Examples and possible signs of child abuse
- Responding to disclosures of abuse
- Grooming behaviours in child sexual abuse
- Mandatory reporting of child sexual abuse
- Department of Communities Mandatory Reporting system.

- Defining child sexual abuse
- Child sexual abuse offender motivation
- Defining and contextualising grooming in child sexual abuse

Teen Talk

Teen Talk draws on current trends and evidence to teach abuse prevention concepts to adolescents. The program educates and empowers young people to have safe, respectful, and positive online and in-person experiences. Whether you use the Protective Behaviours Program, Keeping Safe Child Protection Curriculum or another abuse prevention program, Teen Talk is ideal to facilitate dialogue with young people about tricky topics.

The program is offered across five streams:

1. Abuse Awareness
2. Online Safety
3. Relationship Abuse
4. Consent
5. Pornography Literacy



Each stream is 90 minutes and can be delivered as a single session, concurrently, or as a series to small or large groups of young people.

Each Teen Talk program is customised to the age and developmental level of the group.

Let's talk about Abuse Awareness (Years 6 & 7)

This session provides a review of abuse prevention principles with a focus on personal space, consent, and assertiveness. Young people explore their personal space boundaries with different people and settings. Young people learn about assertiveness, and how they can use these skills in maintaining their right to safety.

Let's Talk About Abuse Awareness (Years 8 to 12)

This session defines sexual abuse and how common it is in our community. Young people will explore common misconceptions and explore the concept of consent in relation to personal space and the law. The session helps young people recognise grooming behaviours as they relate to abuse. Young people will learn how to access support, and the importance of being persistent in seeking help. (Lived experience presentation also available for this stream).

Let's talk about Online Safety (Years 7 to 12)

This session covers core online safety issues including digital wellness, cyberbullying, digital reputation, youth produced sexual content (such as nudes), grooming, catfishing, and practical help-seeking strategies. This session can be customised to your specific needs.

Let's talk about Relationship Abuse (Years 6 to 12)

Young people participating in this session learn the characteristics of healthy and respectful relationships. Young people are introduced to recognising the signs of unhealthy relationships in the context of friendships and intimate partners. The session provides information about how to access support and introduces legal issues. (Lived experience presentation also available for this stream for upper secondary).

Let's talk about Consent (Years 10 to 12)

The session explores the concepts of consent and coercion and young people's rights to define their personal boundaries within relationships with peers and intimate partners. This session clearly defines consent and coercion, the laws, and how to access support.

Let's talk about Pornography (Years 11 & 12)

Pornography is becoming the most common sex educator for young people. This, along with the high accessibility and violent nature of today's pornography, can have a significant impact on the wellbeing of young people, their perceptions of relationships, and how they view themselves. This session empowers young people to think critically about the impact of pornography and how they can balance this with healthy views of intimate relationships.

Lived Experience Presentations

“From your wound is born your passion.”

A person sharing their story connects on a fundamental human level and brings a rich depth of understanding.

Our trained lived experience presenters, Azelene and Genevieve, combine their personal experiences of abuse with their professional knowledge to remove the shame and darkness that can surround the issues of child abuse and family & domestic violence.

Azelene and Genevieve share their stories with schools, corporate groups, and community groups.

Azelene Williams - domestic violence survivor

Azelene experienced years of physical and emotional abuse in her first intimate relationship as a young woman growing up in South Africa. She emerged a stronger person, and now teaches young people and adults how to identify (un)healthy and (un)safe relationships, and how to safely break free. Her life’s ambition as a published author and activist in the field of domestic violence is to have a positive impact on today’s and future generations.



Genevieve Jones - child sexual abuse survivor



Genevieve survived years of horrific child sexual abuse and domestic violence within her family home. Her story is shocking and saddening, but very much inspiring. After years of struggling with wounds left by these traumas, Genevieve sought help and has turned her pain into something powerful. Genevieve now dedicates her time to educating and empowering people to prevent child abuse and encourage victims to speak out.
